## INSIDE INFORMATION BUSINESS UPDATE

This announcement is made by Good Fellow Healthcare Holdings Limited (the "**Company**", together with its subsidiaries, the "**Group**") pursuant to Rule 17.10(2) of the Rules (the "**GEM Listing Rules**") Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 13 December 2024 (the "Announcement") in relation to, among others, the business update of Beijing Huicheng. Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as those set out in the Announcement.

The Board wishes to provide further information to the shareholders (the "**Shareholders**") and potential investors of the Company in relation to the reasons leading to the temporary suspension (the "**Temporary Suspension**") of the operations of Beijing Huicheng, and the Group's plan and expected timetable to resume the operations of Beijing Huicheng.

As disclosed in the Announcement, following the resumption of operation of Beijing Huicheng in or around April 2024, the recovery of its business had not been satisfactory. In the circumstances, the Board proposed to relocate Beijing Huicheng and upgrade it to a Grade II general hospital (the "**Proposed Upgrade and Relocation**") with a view to improve the Group's financial performance and enhance return to the Shareholders.

In or around November 2024, the management of Beijing Huicheng made a written request to the Health Commission in respect of the Proposed Upgrade and Relocation, and applied for the postponement of the annual inspection as additional time is required to identify suitable sites for the proposed relocation. The Health Commission has granted an approval in principle, but required Beijing Huicheng to suspend its operations and identify the new site (the "**New Site**") prior to December 2025. As such, the Board has resolved to apply for the Temporary Suspension.

It is expected that the New Site will remain in the Dongcheng District of Beijing, with an increased gross site area which would entitle Beijing Huicheng to admit more patients. Nevertheless, if other suitable sites are available, the Board will not rule out the possibility to relocate Beijing Huicheng to districts outside the Dongcheng District of Beijing. After completion of the Proposed Upgrade and Relocation, Beijing Huicheng shall provide comprehensive general hospital services, covering, among others, general medical consultations, prescription of medications and complex surgical operations.

Set out below is the detailed plan and timetable of the Group for the resumption of operations of Beijing Huicheng:

on or before 31 May 2025 The management of Beijing Huicheng to (i) conduct market research to understand the actual demand for medical services, and devise its business strategy; (ii) identify suitable sites for resumption of operation of Beijing Huicheng based on, among other criteria, accessibility, surrounding facilities and site area; (iii) sign a letter of intent with the relevant lessor in relation to the leasing of the New Site; and (iv) prepare the relevant documents and materials in relation to the resumption of operation of Beijing Huicheng, including not but not limited to the application for the establishment of medical institution, feasibility study report, site selection report and floor plan of the New Site (collectively, the "**Resumption Materials**").

The working capital required for the operation of the general hospital business of the Group will be supported by shareholder's loan and internal resources of the Group. Should suitable opportunities arise, the Company may also consider conducting equity and/or debt fundraising exercise to expand its general hospital business and support future development of the Group.

The Company will keep the Shareholders and potential investors of the Company informed of any material developments in connection with the above by way of further announcement(s) as and when appropriate and in accordance with the requirements of the GEM Listing Rules.
