PROFIT WARNING

This announcement is made by Good Fellow Healthcare Holdings Limited (the “**Company**”, together with its subsidiaries as the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders (the “**Shareholders**”) of the Company and potential investors that, based on a preliminary review and assessment of the latest unaudited consolidated management accounts of the Group for the six months ended 30 September 2025 (the “**Current Period**”) and the information currently available, the Group expects to record a loss of approximately HK\$2.7 million for the Current Period, as compared to a profit of approximately HK\$7.6 million for the six months ended 30 September 2024 (the “**Corresponding Period**”). Despite the fact that the Group expects to record a revenue from its business operations of approximately HK\$10.5 million for the Current Period (Corresponding Period: approximately HK\$10.4 million), representing a similar level of revenue recorded in the Corresponding Period, the expected turnaround from profit to loss is primarily attributable to the absence of the one-off gain in disposal of subsidiaries of approximately HK\$10.5 million recognised in the Corresponding Period.

As the Company is still finalising the unaudited consolidated financial results of the Group for the Current Period (the “**Interim Results**”), the information contained in this announcement is only a preliminary assessment by the Board based on the preliminary assessment of the unaudited consolidated management accounts of the Group and the information currently available, which have not been finalised or reviewed by the audit committee of the Board or auditor of the Company and may be subject to changes and adjustments arising from further review.

The Interim Results may differ from what is disclosed in this announcement. Shareholders and potential investors are advised to read carefully the Interim Results, which is scheduled to be published in November 2025.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
